ORDINANCE NO. O-9-16

AN ORDINANCE AMENDING CHAPTER 99 OF
THE CODE OF THE BOROUGH OF NORTH
CALDWELL WITH RESPECT TO TRAFFIC
REGULATIONS EFFECTING BOROUGH
SCHOOLS

WHEREAS, the Board of Education of the Borough of North Caldwell has raised certain concerns regarding traffic and parking near the Borough's schools; and

WHEREAS, the Governing Body of the Borough of North Caldwell has reviewed the various traffic recommendations made by the Chief of Police of the Borough of North Caldwell in response to these concerns; and

WHEREAS, the Governing Body of the Borough of North Caldwell seeks to promote the safety of the citizens of the Borough, especially children attending the Borough's schools; and

WHEREAS, it is the recommendation of the Chief of Police that certain changes be made to the Code of the Borough of North Caldwell in order to enhance the safety of students travelling to and from schools;

NOW, THEREFORE, BE IT ORDAINED By the Mayor and Council of the Borough of North Caldwell, County of Essex, State of New Jersey as follows:

1. The Code of the Borough of North Caldwell, Schedule II of §99-21, *No Parking Certain Hours*, be and is hereby amended to add the following:

Name of Street	Side	Time Limit	Hours	Location
Knollwood Drive	Both	----	8:00 am to 9:00 am and 2:30 pm to 3:30 pm When Gould School is In session	Entire Length

2. The Code of the Borough of North Caldwell, Schedule XIII OF §99-32, *Left Turn Prohibited Locations*, be and is hereby amended to add the following:

Name of Street	Direction of Travel	Prohibited Turn	At Intersection of Travel
Gould Avenue	West	Left	Entrances to Gould School Property
Hamilton Drive East	East	Left	Entrances to Grandview School Property

3. The Code of the Borough of North Caldwell, Schedule XIV §99-33, *U-Turn Prohibited Locations*, be and is hereby amended to add the following:

Name of Street	Limits
Gould Avenue	Mountain Avenue to Park Avenue
Hamilton Drive East	Hamilton Drive North to Beachmont Terrace

4. The Code of the Borough of North Caldwell, Schedule III §99-22, *No Stopping or Standing* being and is hereby amended in that all references to Knollwood Avenue be and hereby are deleted.

5. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
6. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
7. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
