### **RiseLeague Guidelines:**

League Dates: Every Friday July 1st-July 29th. Saturday, July 30th Championship.

Contests are 3v3 games to 21 points going by 2s and 3s.

The league will be capped at 8 teams (40 players). All Players must be current high school students, no older than 17 years of age.

2 games will be played each week by each team.

After 4 weeks, teams will be seeded for playoffs. 7 teams will make playoffs, the number 1 seed will have a first-round bye.

Players are fouled out of games on their 4th personal foul. After 5 team fouls, free throws will be, 1 shot for 2 points.

After every made shot to be cleared beyond the 3-point line but the team who was scored on, and treated as a live possession. The high school lines are the format for distances.

Each team is allowed 2 substitution players, for a total of 5 players per team.

The fee for teams is \$100 per player. \$500 per team.  
Individuals not coming as a part of a team, will be assigned to an open slot on a team.

The championship team will win \$1000.00.
