The hierarchy works as follows: We applied for loan with 100% forgiveness which once it was approved, it was put into a separate account at the Amegy account which is controlled by the Secretary of Estate. We have an account that the Town of Woodloch set up as a Projects Account, that is the account that I am trying to remove Diane L. Lincoln off of. This account is linked to the Amegy account only through wire transfer and any requests of funds have to go through an approval process by a committee before funds can be released into the Projects Account so the vendors can be paid. Bid came at \$29,900 but decided to go with Mr. McDonald as he would give us 90 days to pay the bill after completion.
- Town cleaning is going very slowly but we are continuing to make an effort as the days get warmer and sunnier.
