Recently, buildings, carports and sheds have had to be removed at the owner's expense for violation of deed restrictions and city ordinances. The cost to remove or change un-approved construction can be significant. 

CONGRATULATIONS - KEVIN RINGELMAN

Kevin Ringelman, associate professor in the LSU School of Renewable and Natural Resources (and Sherwood Forest resident), has been named recipient of the prestigious H. Dale Hall Ducks Unlimited Endowed Professorship in Wetlands and Waterfowl Conservation. Named after LSU College of Agriculture alumnus and former director of U. S. Fish and Wildlife Service under George W. Bush, the endowment seeks to “perpetuate a faculty position in the LSU School of Renewable Natural Resources, supporting excellence in teaching, research and public service in waterfowl ecology, waterfowl habitat management or wetlands conservation, in cooperation with Ducks Unlimited and other partners.”

As one of nine endowed waterfowl chairs/professorships in North America, this is the only one in the United States to be associated with Ducks Unlimited, Inc., widely recognized as a world leader in wetland and waterfowl conservation.

“One of the central responsibilities of the H. Dale Hall Professor is to make sure the management decisions of Ducks Unlimited and our agency partners are founded in strong and transparent science,” Ringelman said.

Ringelman, who has pursued waterfowl science since 2007 when he attended graduate school at the University of California, Davis, has an impressive background, which includes 30 peer-reviewed papers on the subject and 60 conference abstracts. Since starting at the LSU AgCenter in 2014, his grants in support of waterfowl research exceed \$1.6 million, including substantial financial support directly from Ducks Unlimited. “And it’s a great honor to represent the legacy of Dale Hall and the Ducks Unlimited conservation mission.”

Nearly 100 LSU undergraduate and graduate students have taken Ringelman’s course on waterfowl and ecology management, and his materials are widely shared for use in courses from Colorado State University to the University of Delaware, as well as other universities throughout the U.S.

"My research and training priorities have always been closely aligned with those of Ducks Unlimited," Ringelman said. "And it's a great honor to represent the legacy of Dale Hall and the Ducks Unlimited conservation mission."

BATON ROUGE FINE ARTS SCHOOL TO OPEN ON OLD BROADMOOR MIDDLE SCHOOL SITE

Broadmoor Middle School opened at the corner of Goodwood Boulevard and Sharp Road in 1960 and was initially known as Broadmoor Junior High. At the time, Goodwood Boulevard ended at Sharp Road, the easternmost boundary of Broadmoor subdivision. Goodwood Boulevard did not extend further east across Jones Creek into the new Sherwood Forest Subdivision until the bridge and the Goodwood Boulevard alignment project was completed in 1964/65 about the time that the Seventh and Eighth Filings of West Sherwood Forest opened. Broadmoor Middle served many students in our neighborhood and the Greater Baton Rouge community so well for almost 60 years, but it was closed in 2019 because of declining enrollment.

So, it came as wonderful news for our area in 2021 when Dr. Sito Narcisse, the Superintendent of Schools of the East Baton Rouge Parish School System, had the vision to push to convert the old Broadmoor Middle School site into a dedicated conservatory. Dr. Narcisse had worked in cities with similar schools, and he organized a trip with six school board members in the fall of 2021 to travel to Miami to visit arts-focused magnet schools and glean some ideas about how to replicate their success. He received the unanimous approval for this conversion from the members of the East Baton Rouge School Board on November 18, 2021.

A conservatory is a school dedicated to the visual and performing arts. The conservatory model will be the first of its kind in Baton Rouge. Before this development, the old Middle School site had already been in line for \$15 million in renovations, and this money will now be used for development of the new school.

This new “magnet” school is scheduled to open in the fall of 2023. The school is projected to serve students in grades 6-12 once fully enrolled. Some have referred to the proposed new school as the “Julliard of Baton Rouge”—where local teenagers can cultivate their skills for possible careers in music, film, dance, theater, and visual arts. Provisionally called Baton Rouge School for the Arts or Baton Rouge Conservatory of the Arts, the new school would enroll an estimated 700. It would educate middle school age students the first year and then add high school grades a year later in the fall of 2024. Two elementary schools that focus on visual and performing arts will feed into the new school—the Baton Rouge Center for Visual and Performing Arts, presently located at 2040 South Acadian Thruway (for old timers in Baton Rouge, the old Walnut Hills Elementary) and Broadmoor Elementary.

School Board member, Mark Bellue, who represents our area, graciously spoke to our full Sherwood Forest Citizens Association (“SFCA”) Board to provide information and answer our questions before the EBR School Board final vote. In mid-March, Dr. Narcisse and EBR Schools Director of Fine Arts, Sean Joffrion, sat down with SFCA Board members, including Board President Debra Simino, to describe their vision and plans for the school. Multiple conservatories will include visual arts, instrumental and vocal music, theater arts both musical and acting, dance, and television & media (with a major focus on film). They envision a school that will truly be a “Julliard” school that will bring wide acclaim to the EBR School System and to the entire Greater Baton Rouge region. To ensure its success, there is a volunteer advisory group of approximately 20 EBR citizens, all or most of whom have backgrounds in the arts. Dr. Narcisse offered Sherwood Forest a seat on this committee. Kathy Balhoff, who grew up in Broadmoor, has lived for many years in Sherwood Forest, and is an accomplished musician serves as the Sherwood Forest representative on the advisory committee.



GOODBYE CORTANA MALL & HELLO AMAZON!

Cortana Mall - Changing Times Ends Era

The explosion in online shopping has ended the heyday of million square foot shopping malls across the country. Baton Rouge's former Cortana Mall was one of the casualties. Built on former plantation acreage Cortana Mall opened on August 4, 1976, and at 1.3 million square feet it was the largest indoor mall in the south. During its peak it boasted 100+ stores for shoppers to enjoy.

After a 45+ year run, Baton Rouge population shift, and digital shopping eventually spelled doom for Cortana Mall (and other malls across the country). Online shopping sites have seen huge increases in sales over the past decade while in-store retail sales have been mostly declining (depending on the store). After a series of failed attempts to keep Cortana Mall relevant, it was eventually closed for good in 2021.

2022 saw the demolition of the old Cortana Mall buildings to make way for Amazon's new 1 million square foot Fulfillment Center. On top of Amazon's industry-leading minimum starting wage of \$15 per hour, 1000+ full-time employees will receive comprehensive benefits, including full medical, vision and dental insurance as well as a 401(k) with 50 percent company match. Amazon employees will pick, pack, and ship smaller customer items such as books, toys, electronics, and other household items from the new facility. Baton Rouge is looking forward to Amazon's successful efforts investing in our city and revitalizing this area of town.
