**RE: Proper Criminal Charges for Baltimore
Cops Who Killed Freddie Gray**


Dear Ms. Darden,

I wish to impress the following material legal issues ignored during prosecution of the Baltimore police officers who slain your son, Freddie:

1. Criminal prosecutions require “jury trials” under the 6th Amendment. Trial by a judge issuing a verdict is unconstitutional. – See attached the 6th Amend.
2. Baltimore prosecutor Marilyn Mosby filed the improper charges of murder (so the officers would go free). But the proper charges are **negligent homicide, criminal negligence**, and **official misconduct**. “Negligence” has a much lower burden of proof, of which the officers violated procedures leading to the death of Freddie. **(Charging the already cleared officers with these newly discovered offenses is not “double jeopardy.”)**
3. The officers broke Freddie’s neck prior to him being taken to the police van. Freddie was: **a)** not given medical attention at time of officers’ crippling blunt force, **b)** incapacitated when, **c)** carried to the van, since he **could not** walk. And **d)** Freddie died from those injuries. Thus, the van **could not** have caused Freddie’s death.
e) Was Freddie stopped lawfully? **f)** Was his arrest lawful? **g)** Why did officers’ use crippling blunt force? (Negligence is showing evidence of blunt force; not who did it.)
4. What did the arresting Police officers “report?” Officers are required to fill-out Police reports on their calls handled & witnessed. Refusal to do so **interferes with the state’s official business** & obstruction of justice; requires officers’ job terminations & criminal prosecutions. Officers submitting “false information” in a Police report criminally commit: **A)** obstruction of justice, **B)** submitting false reports, & **C)** official misconduct.

Ms. Darden, you may pursue prosecution of the Baltimore officers along the above actual law. You may see some of my other work at www.Prose-Litigants.org and www.The-Louisville-Underground.org. – *May GOD be with you.*

U.S. Constitution

6th Amendment (of *Bill of Rights*)

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, **by an impartial jury of the State and district wherein the crime shall have been committed**, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defense.
