ORDER GRANTING SUMMARY JUDGMENT

The Plaintiffs having responded to Daniel Cobble's Motion for Summary Judgment with their own Cross Motion for Summary Judgment and the Court finding that that there are no genuine issues of material fact, that the Plaintiffs are entitled to judgment as a matter of law and that UCC Financing Statements 2012-2603243-05.01 (Named Debtor: Louisville Transportation Company), 2012-2603246-38.01/02 (Named Debtor: Middleton Reutlinger PSC) and 2012-2603245-27.01 (Named Debtor: Kentucky Department of Treasury) were filed fraudulently, in bad faith and do not meet the statutory requirements of the Uniform Commercial Code;

IT IS HEREBY ORDERED AND ADJUDGED:

1. That the above listed UCC Financing Statements have no legal effect and are deemed null and void;
2. That the Secretary of State shall remove the above listed Financing Statements from her records;

3. That a permanent injunction pursuant to CR 65.01 be granted against Cobble and the Kentucky Secretary of State permanently enjoining him from filing any additional UCC Financing Statements against the Plaintiffs and further enjoining the Secretary of State from accepting any financing statements from Daniel Cobble naming the Plaintiffs as debtors; and

4. That Plaintiffs be awarded their attorneys' fees and costs.

This is a final and appealable Order.
