NOTICE OF APPEARANCE

1. Now comes Defendant Daniel Cobble (as Cobble) under common law and pursuant to Cobble's pending Dec. 29, 2012 *Counterclaim*, to give Notice to the Court he will appear at **Motion Hour** on **Monday, April 8, 2013** at **11:45 a.m.** for the attached Motion to ratify Cobble's Liens #2012-2603246-38.02, #2012-2603243-05.01, and #2012-2603245-27.01 as a matter of procedure and administrative process.

2. To wit, **this Court's Mar. 20, 2013 order is ineffective** for removing the liens (*supra*) from the Secretary of State's (**SoS**) commercial *Registry* record, since the SoS cannot remove the liens from the Registry. For no evidence of the liens being administratively invalid has been provided to the SoS. - Counsels for Plaintiffs are fraudulently obstructing processing of the liens by providing misleading and false information to the Court.

3. To wit, attached, hereto, are the SoS's three **March 27, 2013** *Certificates* certifying Liens #2012-2603246-38.02, #2012-2603243-05.01, and #2012-2603245-27.01 remain in the SoS's Registry as valid liens.

Wherefore, the liens remain before the Court, as the Court is required to ratify the liens as a matter of procedure and administrative process.
